1. Car must be returned clean and free of garbage. A cleaning fee of EC\$20 will apply for smoke odors, ash residue, vomit, excessive dirt, or food/drink spills.
 2. Vehicles are to be driven on paved roads only. A cleaning and inspection fee of EC\$30 may apply if this condition is violated.
 3. Flat tires caused by road hazards are the renter's responsibility.
 4. Renter is responsible for maintaining oil and water levels in the vehicle engine. Failure to maintain fluid levels resulting in engine damage will make the renter liable for repair costs.
 5. If the vehicle overheats, the renter must immediately stop driving and contact the company. Failure to do so will result in full liability for repair costs.
 6. Parking tickets and traffic violations are the renter's responsibility. Unpaid tickets may incur an EC\$80 administrative fee.
 7. If the vehicle breaks down, is stranded, or requires towing for reasons other than normal mechanical failure, the renter assumes responsibility for towing and repair costs.
 8. Broken glass not caused by another driver in an accident is the renter's responsibility.
 9. Unauthorized airport drop-offs will incur an EC\$60 charge.
 10. Vehicles must be returned on or before the agreed return date and time. Late returns will be charged at the maximum daily rental rate.

Rental Agreement Terms and Conditions

1. Definitions

“Agreement” means all terms and conditions found on both sides of this form, any addenda, and any additional materials provided at the time of rental.

“You” or “your” means the renter, any person signing this agreement, any authorized driver, and any person or organization to whom charges are billed.

“We,” “our,” or “us” means Elite Way Rentals and Transfers.

“Authorized Driver” means the renter and any additional driver approved by us, possessing a valid driver’s license and between the ages of 25 and 65 years.

“Vehicle” means the automobile identified in this agreement, including all tires, tools, accessories, keys, equipment, and documents.

2. Rental

This agreement is a contract for the rental of the vehicle. We make no warranties, express or implied, regarding the vehicle’s condition or suitability for a particular purpose.

3. Condition and Return of Vehicle

The renter agrees to return the vehicle in the same condition received, except for ordinary wear and tear.

4. Responsibility for Damage or Loss

The renter is responsible for all damage, theft, loss of use, administrative fees, towing, and related expenses.

All accidents, thefts, or incidents must be reported immediately to both the police and Elite Way Rentals and Transfers.

5. Liability Insurance

Liability and collision coverage are provided according to the commercial insurance policy issued for self-drive rental vehicles in Saint Lucia.

Collision Damage Waiver (CDW) is included in the base rate and limits renter liability subject to adherence to all terms of this agreement.

Optional Extra Protection (EP) further limits renter liability where applicable.

Coverage becomes void if:

- The vehicle is driven by an unauthorized driver
- The renter violates this agreement
- The renter fails to cooperate with investigations
- The renter operates the vehicle under the influence of alcohol or drugs
